The 22nd International Symposium on Society and Resource Management (ISSRM) will be held at the Michigan Technological University in Houghton, Michigan, USA on the Keweenaw Peninsula near Lake

Superior. The 2016 ISSRM will offer excellent opportunities to engage a diverse community of scholars, practitioners, and decision-makers and to experience Yooper (Upper Peninsula of Michigan – or "U.P.") culture in person. Along with the typical complement of activities – e.g., student forum, quiz bowl, posters, presentations, and organized sessions – the 2016 ISSRM will foster creativity and disciplinary integration through excellent keynote speakers, social events, field trips, and local recreational opportunities.

The 2016 ISSRM theme is Transitioning: Toward Sustainable Relationships in a Different World. Climate change, environmental degradation, and resource limitations as well as globalization and demographic transitions, have created a present and future world very different from the industrialization and limitless economic growth of the nineteenth and twentieth centuries. Our world is facing serious social and ecological (socioecological) transitions. Agencies, governments, communities, and businesses are struggling to adapt to these new realities

that are increasingly challenging hegemonic social relationships with the natural world. The theme "Transitioning" seeks to capture the fear, urgency, excitement, opportunities, and challenges associated with the myriad socioecological changes facing the international community.

# **Elections Committee**

IASNR strives for the organizational leadership to be "broadly representative of the membership reflecting a balance of: (1) disciplinary orientations in the social sciences; (2) natural resource management fields; and (3) professional practice" (e.g., academic and agency scientists; resource managers; domestic and international scholars; mid-career and seasoned professionals). Service on the IASNR Council affords members the opportunity to contribute substantially to current operations and future directions of the organization. The Council has approved proposed amendments to the IASNR Bylaws to reduce the term of service for Executive Officer and professional Council positions from four to three years. This would result in a three-year cadence for positions, with three of the nine professional Council positions, along with the new Student Representative-Elect position, elected every year; and Executive Officer positions elected every three years. Under the proposed process, the next call for nominations would be issued in late 2016 and elections would be held in early 2017. The proposed amendments to the election process and term

of service are currently under consideration by the membership for approval at the IASNR General Assembly in June at the 2016 ISSRM.

## IASNR Governance Update

The IASNR Council met in February to discuss a number of topics related to IASNR governance, operations, and activities. This included taking a look at organization objectives, membership characteristics, student engagement, Executive Officer, Council, and Committee roles and responsibilities, and memberand community-of-practice- oriented products and services (e.g., publications, ISSRM, professional development opportunities). The Council discussed and approved several actions and associated amendments to the IASNR Constitution and Bylaws to improve consistency, efficiency, and transparency for the organization. In accordance with the provisions of the Constitution and Bylaws, a notification and solicitation for review and comment was distributed via email to the membership in March. A brief summary of the proposed changes is included below.

- Establish an organizational Code of Ethics outlining appropriate and expected conduct, professional standards, associated policies and procedures, oversight, enforcement, and sanctions. Agreement with the conditions of the IASNR Code of Ethics will be a standard requirement for all members and participants in IASNR events, programs, and activities (see "Review" link below for additional details).
- Establish as a permanent Standing Committee, an
  Ethics Committee responsible for promoting ethical conduct of members, investigating complaints
  concerning the ethical conduct of members, and
  imposing sanctions when violations of the
  IASNR Code of Ethics have occurred (see
  IASNR Constitution Article 8.2).
- Establish as a permanent Standing Committee, an Audit Committee responsible for oversight of the organization's bookkeeping and financial reporting processes, selection of the external auditor, and development and oversight of strategies implemented for internal control and risk manage-

ment (see IASNR Constitution Article 8.3).

- Reduce the term of service for IASNR Executive Officer and professional Council positions from four years to three years (see IASNR Bylaws Article 6.4 and 7.3).
- Modify frequency of elections for Executive Officer positions from every four years to every three years (see IASNR Bylaws Article 7.4).
- Modify frequency of elections for professional Council positions from biennial to annual, with solicitation for nominations and elections for three of nine professional Council positions, and the Student Representative-Elect position, held every year (see IASNR Bylaws Article 6.7).
- Standardize term of service start/end dates for Executive Officer and Council positions to coincide with IASNR fiscal year, January 01-December 31 (see IASNR Bylaws Article 6.4, 6.5, and 7.3).

Please review and provide comments, indicating the specific Article and corresponding document (i.e., constitution or bylaws) for each. Comments must be submitted by email to IN-FO@iasnr.org no later than June 15, 2016. All submitted comments will be reviewed and compiled for presentation before the IASNR General Assembly at the 2016 ISSRM, where a vote by the membership will be administered to approve the Code of

Ethics and ratify all proposed amendments.
